ARTICLE I-NAME AND PRINCIPAL ADDRESS

The name of this corporation is DRAIN PRO SEWER AND DRAIN

ARTICLE II-DURATION

This corporation shall have perpetual existence commencing on  
the date of this filing of these Articles with the Department of  
State.
