Article I. Name

The name of this corporation is Lake City Mobile Homes Inc, and the mailing address of this corporation is, Post Office Box 7001, Lake City, Fl 32055.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage in any activity of business permitted under the laws of the United States and the State of Florida.

ARTICLE III. POWER

This corporation is authorized and empowered to do all things necessary to carry on and accomplish the purpose for which it is organized and chartered, including all authority and power granted by Florida law.

Section 3: In case of loss or destruction of certificate of stock, no new certificate shall be issued in lieu thereof except upon satisfactory proof, to the officers require to sign the same, of such loss or destructin; and upon giving satisifactory security, by bond or otherwise, against loss to the corporation any such new certificates shall be plainly marked "duplicate" upon its face.

Article V. INITIAL CAPITAL

The amount of capital with which this corporation will begin is not less than Two Hundred Dollars (\$200.00).

Article VI. TERM of EXISTENCE

The corporation is to begin existing August 20, 1999, and perpetually from that day forth.

ARTICLE VII. DIRECTORS
