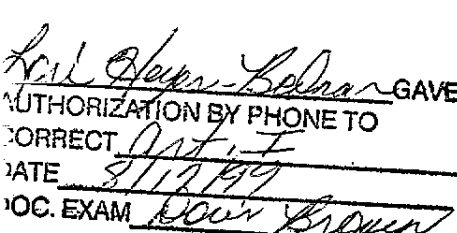

NAME

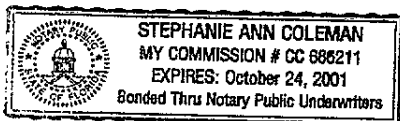
