The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

**ARTICLE I - NAME:**

The name of the corporation is **INTERNATIONAL BIO-SOURCE, INC.**

**ARTICLE II - TERM OF EXISTENCE:**

The duration of the corporation is perpetual and shall commence upon the signing of these Articles.

**ARTICLE III - NATURE OF BUSINESS:**

The general purpose for which the corporation is organized is:

1. To engage in any activity or business permitted under the laws of the United States and the State of Florida.

A. Including bloodtyping samples.

Authorized capital stock may be paid for in cash, services or property Corporation at any regular or special meeting.





**ARTICLE VI - AGENT:**

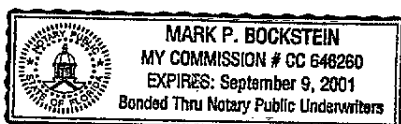

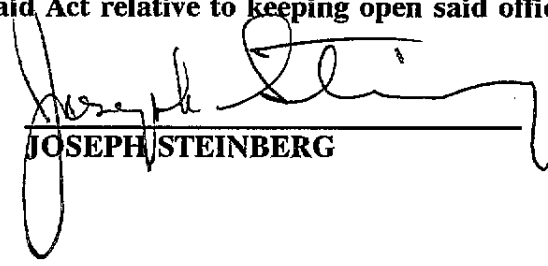
