# ARTICLES OF INCORPORATION OF ROYAL FLORIDIAN BY SPINNAKER, INC.

The undersigned incorporator hereby makes, subscribes, adopts and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit under the Florida Business Corporation Act.

### ARTICLE I NAME

The name of this corporation is ROYAL FLORIDIAN BY SPINNAKER, INC., and its principal place of business and mailing address is 5401 Kirkman Road, Suite 740, Orlando, FL 32819.

# ARTICLE II EXISTENCE OF CORPORATION

This corporation shall begin existence on the date of filing of these Articles of Incorporation with the Secretary of State for the State of Florida and shall have perpetual existence unless sooner dissolved according to law.

# ARTICLE III PURPOSES & GENERAL POWERS

This general purpose of this corporation shall be to engage in the transaction of any lawful business for which corporations may be incorporated under the laws of the State of Florida. This corporation shall have all of the powers enumerated in the Act and all such other powers as are not specifically prohibited to corporations for profit under the laws of the State of Florida.

### ARTICLE IV CAPITAL STOCK

### (A) NUMBER OF SHARES AUTHORIZED; PAR VALUE

The total number of shares of capital stock which this corporation is authorized to have at any one time is 10,000 shares, each having a par value of \$1.00 per share.

### (B) VOTING RIGHTS

Each share of capital stock shall entitle the holder thereof to one (1) vote at any meeting of the shareholders. Shareholders holding capital stock shall have no cumulative voting rights in any election of directors of this corporation.

# ARTICLE V REGISTERED OFFICE AND REGISTERED AGENT

The initial registered office of the corporation is 5401 Kirkman Road, Suite 740, Orlando, FL 32819 and the corporation's registered agent is William C. Edmunds. The corporation may

change its registered agent and/or its registered office at any time by filing a statement with the Secretary of State which complies with § 607.0502, Florida Statutes.

### ARTICLE VI BYLAWS

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors.

## ARTICLE VII INDEMNIFICATION

This Corporation shall indemnify any officer or director, or any former officer or director, to the fullest extent permitted by law.
