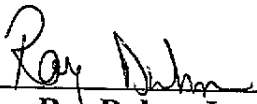

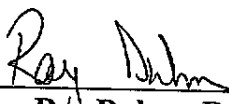
### ARTICLE XI - Dissolution

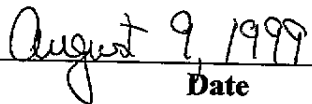
