ARTICLES OF INCORPORATION

ARTICLE ONE

The name of the corporation is "AFPWeb Dot Com", Inc. The principal office and mailing address is 2400 Falkner Road Orlando, Florida 32810.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is one thousand of the par value of dollars (\$1.00) each.

The corporation will not commence business until it has received for the issuance of shares consideration of the value of \$1,000 consisting of money, labor done or property actually received.


ARTICLE SIX
