ARTICLE I - NAME

The name of this Corporation is SJRS, INC. and its address is c/o KWW, 20 North Orange Avenue, Suite 100, Orlando, Florida 32801.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

This Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.


ARTICLE IX - INCORPORATOR


