The members of the first Board of Directors shall hold office until the first annual meeting of the stockholders of the corporation.



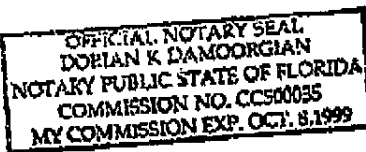
