I am the Controller for this and all the other corporations. Unfortunately, late last year (2002) I was diagnosed with four lesions of brain cancer. Frankly, we cannot afford the \$400.00 fine [which also affects an additional seven corporations] because our filings are late, and at this point in time, I am afraid that my job could be on the line as well.

Therefore, I am requesting that the late filing fees be waived.
