ARTICLES OF INCORPORATION OF MONEY FINDER\$, INC.



The undersigned Subscriber, a natural person competent to contract, desires to form a Corporation under the laws of the State of Florida, and hereby adopts the following Articles of Incorporation for such Corporation.

ARTICLE I. NAME

The name of the Corporation is MONEY FINDER\$, INC., and the principal office and address is: 4204 HERSCHEL STREET, JACKSONVILLE, FL 32210.

ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by this

Corporation is to manufacture, purchase, or otherwise acquire, own,

mortgage, pledge, sell, assign and transfer, or otherwise dispose of,

to invest, trade, deal in and deal with goods, wares, and merchandise

and real property of every class and description, and to carry on and


