

**Articles Of Incorporation
Of
Krishna America, Inc.
(A Florida Corporation)**

**Article I
NAME**

The name of this Corporation is Krishna America, Inc..

**Article II
PURPOSE**

This Corporation is organized for the purpose of any and all lawful business in the State of Florida.
