Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation which changes the name of the Corporation:

**ARTICLE I**

The name of the Corporation is G & L SHELL CONTRACTORS, INC.

**ARTICLE II**

The following amendments to the Articles of Incorporation were duly adopted by the Shareholders of the Corporation effective as of the 1<sup>st</sup> day of February, 2006, to change the name of the Corporation. The Amendment alters or changes Article I of the original Articles of Incorporation and the full text of each provision altered is as follows:

**"ARTICLE I**
