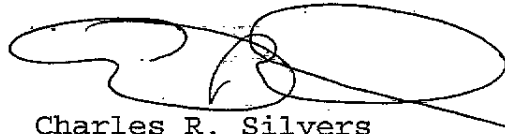

The corporation may change the number of its officers and directors at any time by the nomination and election thereof.

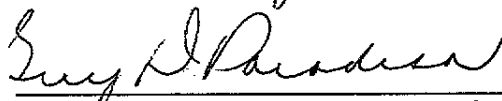
