I did not receive this mailing until June 10, 2000 due to the fact that the Apt. #212 was deleted from the address that was mailed to me.

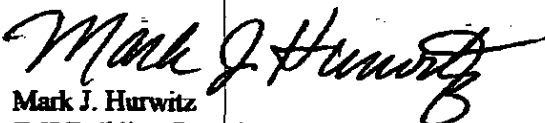
The apartment complex office handed it over to me when I gave them my notice to vacate to my new address (400 Golf Brook Circle #108).
