WHEREAS, all of the business of the Company has been concluded and it is in the best interests of the Company to be dissolved,

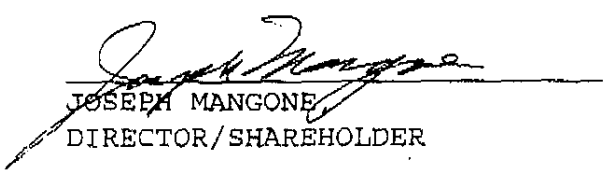
NOW, THEREFORE:

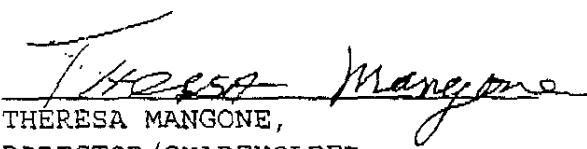
BE IT RESOLVED, that the dissolution of the Company is unanimously adopted, approved and consented to by the undersigned Directors and Shareholders; and
