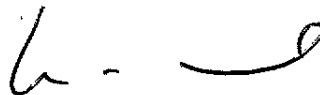

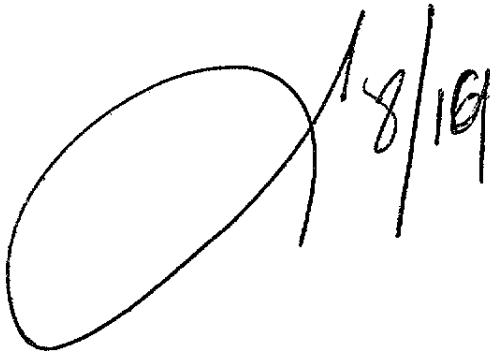

ARTICLES OF INCORPORATION

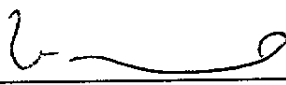
