ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, competent to contract, hereby associates and forms a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is EAFF (USA), INC.

ARTICLE II

The general nature of the business to be transacted by this corporation is to enter into any and all aspects of the freight forwarding and merchandising business, or any other lawful purpose. It shall have every corporate power granted by the Florida Legislature.

ARTICLE III

The maximum number of shares of stock which this corporation is authorized to have outstanding at any time is one hundred (100) shares of common stock, \$1.00 par value.

This corporation shall have perpetual existence.



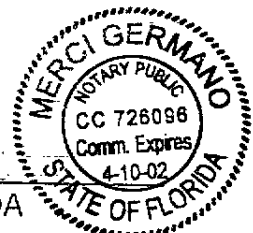


