ARTICLE V – REGISTERED AGENT

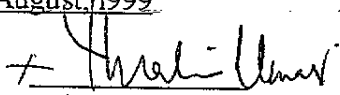

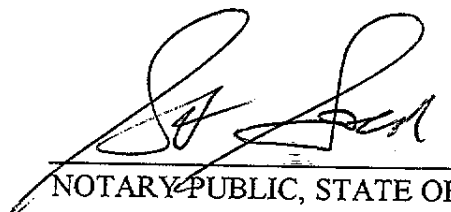

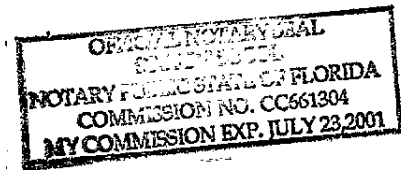
