GENERAL PROVISIONS


(a) The private property of the stockholders shall not be

its Board of Directors.



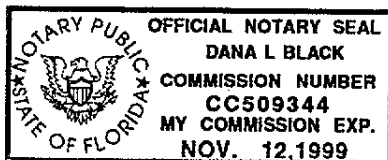


