Dear Sir/Madam:

The undersigned is the president of David R. Slaton, P.A. On July 6, 2000, I received a notification from the Division of Corporations that advised that the corporation's Uniform Business Report was never received by the Division. This was surprising to me as I had sent David R. Slaton, P.A.'s Uniform Business Report to the Division of Corporations on April 27, 2000. The Uniform Business Report was sent via Airborne Express. Enclosed, please find a photocopy of the Airborne Express receipt indicating that the document was shipped on April 27, 2000. The records of Airborne Express reflect that a "B Sippio" at the Division of Corporations received the package. Enclosed please find a copy of an original invoice from Airborne Express reflecting this. Additionally, after I received the notification on July 6, I contacted Airborne Express who faxed me a copy of the original air bill indicating that "B. Sippio" received the uniform business package on April 28, 2000.

Enclosed, please find a copy of the 2000 Uniform Business Report which was received by "B. Sippio" along with a copy of my firm check 953 in the amount of \$150.00 for the filing fee. I have reviewed my bank account statements and I note that check number 953 has not been cashed. Therefore, it is likely that the Airborne Express package received by "B.
