The undersigned, for the purpose of creating a corporation under the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

**ARTICLE FIRST: NAME OF CORPORATION**

The name of the corporation is WC-Express, Inc. The principal office of the corporation is located at 6311 Atrium Drive, #100, Bradenton, Florida 34202; and the mailing address of the corporation shall be the same.

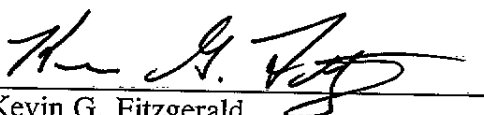
