ARTICLES OF INCORPORATION

OF

ORETOB AIR, INC.

ARTICLE I

The name of the corporation is **ORETOB AIR, INC.** (the "Corporation").

ARTICLE II

The address of the principal office and the mailing address of the Corporation is *c/o International Satellite Telecommunications, Inc., 2977 McFarlane Road, Coconut Grove, Florida 33133.*

ARTICLE III

This Corporation shall have authority to issue One Thousand (1000) shares of Common Stock having a par value of *\$0.01* per share.

ARTICLE IV

The Corporation shall hold a special meeting of shareholders only:

- (1) On call of the Board of Directors or persons authorized to do so by the Corporation's Bylaws; or
- (2) If the holders of not less than 50 percent of all votes entitled to be cast on any issue proposed to be considered at the proposed special meeting sign, date, and deliver to the Corporation's secretary one or more written demands for the meeting describing the purpose or purposes for which it is to be held.

This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.

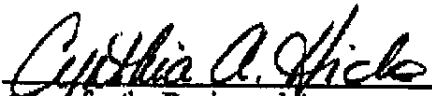
