The undersigned, desiring to form a professional corporation in accordance with the law of the State of Florida, for the practice of law, does hereby adopt the following Articles of Incorporation.

ARTICLE ONE

NAME

The name of the corporation shall be L. Murray Fitzhugh, P. A..

ARTICLE TWO

PURPOSES

The purposes for which the corporation is organized are as follows:

- (1) Primarily to engage in the specific business of the practice of law as a law corporation.
- (2) To engage generally in the business of a law corporation as the same is now or hereafter defined by statute, rule and regulation, and in connection therewith to own property, to enter into contracts, and to transact any lawful business related thereto.

ARTICLE SIX

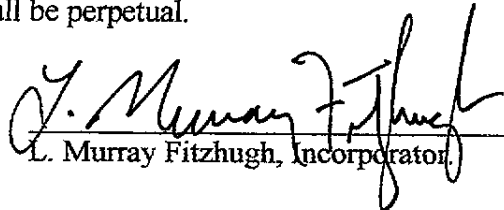
INITIAL CAPITAL

The amount of stated capital with which the corporation shall begin business is Five Hundred Dollars (\$500.00).

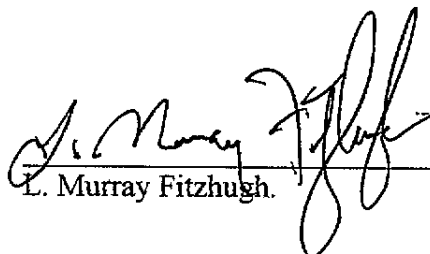
ARTICLE SEVEN
