The term for which this corporation shall exist shall be perpetual.

The general nature of the business or businesses to be transacted by said corporation shall be as follows:

To own, lease, maintain, or otherwise conduct businesses related to the production, dissemination, recording, writing, copying, performing, sales or distribution of music, whether in recorded or written form; or anything related to the ownership, lease, sale of music rights or representation of such owners or lessors of music rights; or the management of such businesses or musicians or composers;
