**ARTICLE I**

**CORPORATE NAME**

The name of the Corporation is Florida Westcoast Produce, Inc.

**ARTICLE II**

**PLACE OF BUSINESS**

The principal place of business for Florida Westcoast Produce, Inc. will be 5207 North 30th Street, Tampa, Florida, 33610-5103.

**ARTICLE III**

**PURPOSE**

The purpose of the Corporation is to engage in the wholesale purchase and distribution of farm produce.

**ARTICLE IV**

**REGISTERED OFFICE/AGENT**

The number of directors constituting the initial Board of Directors of the Corporation is 2 (two).



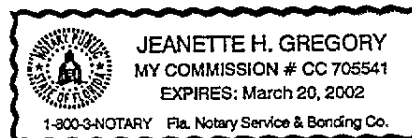


