Best Ball Inc., has no loans outstanding or assets.

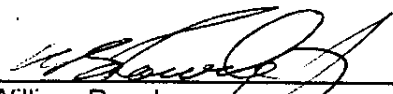
Chad Czarnecki agreed to and accepted this transfer with no recourse to William Rowden.
