ARTICLE I

The name of this corporation shall be eTEA PIONEERS IN NATURAL MEDICINE, INC.

ARTICLE II

The principal office and mailing address of this corporation shall be 6223 Chauncy St., Tampa, FL 33647.

ARTICLE III

This corporation is formed for the purpose of conducting any business or business transaction lawfully permitted by the Florida Business Corporation Act.
