Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

**Article I - Name**

The name of the corporation is FUSADOT.COM, INC. (hereinafter referred to as the "Corporation").

**Article II - Adoption and Text of Amendments**

All of the directors of the Corporation approved a resolution amending Article 1 of the Articles of Incorporation by written consent dated July 3, 2000 in accordance with the provisions of Section 607.0821 of the Florida Statutes, and all of the shareholders of the Corporation approved the resolution amending Article 1 of the Articles of Incorporation by written consent dated July 3, 2000, in accordance with the provisions of Section 607.0704 of the Florida Statutes.
