Anunciata Miranda, hereby certifies as follows:





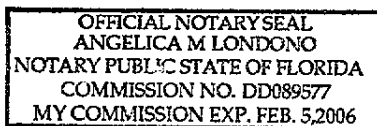
