CORPORATE NAME AND PRINCIPAL OFFICE



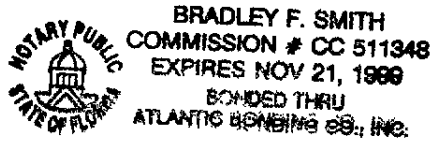


