2. That the Corporation was administratively dissolved by the Florida Department of State on September 22, 2000.
3. That the Corporation failed to file its 2000, 2001 and 2002 Annual Report or pay the 2000, 2000, 2002 and 2003 Annual Report filing fee within the time prescribed by Florida Statutes Chapter 607 because:
