THE UNDERSIGNED INCORPORATOR to these Articles of Incorporation,
natural person competent to contract, hereby form a corporation for
profit under the laws of the State of Florida.

ARTICLE ONE

The name of this corporation is Negron, Inc.

ARTICLE TWO

This corporation shall have perpetual existence.

ARTICLE THREE

This corporation shall be effective upon approval by the Secretary
of State of the State of Florida.

ARTICLE FOUR

The corporation may engage in any activity or business permitted
under the laws of the United States and of this State.

ARTICLE FIVE

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 500 shares of common stock, each having a \$2.00 par value.

ARTICLE SIX

It is the intent of the incorporators that the corporation may wish to qualify under Section 1244 of the Internal Revenue Code and that the corporation may if it desires file as a Subchapter S corporation.

ARTICLE SEVEN

The initial street address of the principal office of this corporation is to be at 949 Fountainhead Drive, Deltona, Florida 32725. The Board of Directors may, from time to time, move the principal office to any other address in Florida.

ARTICLE EIGHT

ARTICLE NINE




