# ARTICLES OF INCORPORATION

### ARTICLE I

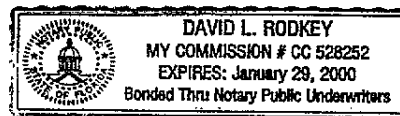
