### ARTICLES OF INCORPORATION

### ARTICLE I NAME

The name of the Corporation is SHARON L. PERDUE, CPA, P.A.. The address of the Corporation is 1218 Beacon Hill Drive, Tampa, Florida 33613.

### ARTICLE II DURATION
