ARTICLES OF INCORPORATION  
OF

ARTICLE I -- NAME

The name of this corporations is Advanced Estate Concepts, Inc.

ARTICLE II -- DURATION

This corporation shall have perpetual existence commencing on September 1, 1999.

ARTICLE III -- PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business including, but not limited to, financial planning services.


