ARTICLE I - NAME

The name and address of this corporation is: **TO ENTERTAIN, INC., 5427 N.W. 48th Street, Coconut Creek, FL 33073.**

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of filing of these Articles.


