

The undersigned incorporator hereby forms a corporation under Chapter 607.0732, Fla. Stat., of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

Tura's Sheet Metal Fabrication, Inc.

The address of the principal office of this corporation shall be 461 - 23rd Avenue North, St. Petersburg, Florida 33704, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS

This corporation shall be generally engaged in the manufacture of sheet metal products. This corporation may engage in all activities and shall have all powers lawful for corporations for profit, pursuant to the general corporation laws of the State of Florida.

ARTICLE III. CAPITAL STOCK

The corporation is authorized to issue 300 shares with a par value of \$.10 each.

ARTICLE IV. NUMBER INITIAL CAPITAL

This corporation shall begin business with not less than \$500.00 of capital paid in by subscribing initial shareholders.

ARTICLE V. NUMBER CORPORATION EXISTENCE.

This corporation shall have perpetual existence.

ARTICLE VI. PRINCIPAL OFFICE

The initial principal office of this corporation shall be 461 - 23rd Avenue North, St. Petersburg, Florida 33704. The corporation shall establish other offices, including other principal offices, within and without the State of Florida, but shall always maintain a principal place of business within the State of Florida.

ARTICLE VII. MANAGEMENT BY SHAREHOLDERS

Pursuant to Chapter 607.0732, Fla. Stat., this corporation shall not have more than 100 shareholders at one time. The undersigned incorporators shall be the initial shareholders of the

corporation. This corporation shall have no Board of Directors, and the shareholders of the corporation shall exercise all corporate powers and manage the business and affairs of the corporation as managing shareholders. The initial shares of the corporation shall be subscribed as follows:



ARTICLE VIII. REGISTERED OFFICE AND REGISTERED AGENT



Wherefore, the above names incorporators have executed these articles of Incorporation this 12 day of July, 1999.



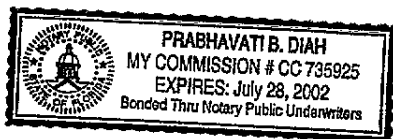
