**ARTICLES OF INCORPORATION
OF
TitanSearch, Inc.**

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

Article I. Name

The name of the corporation shall be:

TitanSearch, Inc.

The address of the principal office of this corporation shall be 444 Brickell Avenue, Suite 805, Miami, Florida 33131 and the mailing address of the corporation shall be the same.

Article II. Nature of Business

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

Article III. Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 20,000,000 shares consisting of 18,000,000 shares of common stock having no par value per share (the "Common Stock"), and 2,000,000 shares of preferred stock, having no par value per share (the "Preferred Stock").

Article IV. Registered Agent

Article V. Term of Existence

This corporation is to exist perpetually.




