## **ARTICLES OF INCORPORATION**

### **OF**

### **LAFAYETTE MOTEL, INC.**

The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida General Corporation Act, adopts the following Articles of Incorporation:

#### **ARTICLE I -- NAME OF CORPORATION**

The name of this corporation is **LAFAYETTE MOTEL, INC.** and its principal place of business shall be located at 1525 W Tennessee Street, Tallahassee, Florida 32304.

#### **ARTICLE II -- TERM OF EXISTENCE**

This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Department of State.

#### **ARTICLE III -- GENERAL PURPOSES**

The general purpose for which the corporation is organized shall be to conduct and transact any and all lawful business authorized and not prohibited by the Florida General Corporation Act, as the same may be from time to time amended.
