Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, ACCESS USA.com INC., adopts the following Articles of Amendment to its Articles of Incorporation:


1. The name of the corporation is ACCESS USA.com INC.
2. The original Articles of Incorporation for the corporation were filed on August 25, 1999, and assigned Charter No. P99000075853.
