ARTICLES OF INCORPORATION OF BHCOMMUNICATIONS, INC.

The undersigned subscriber to these Articles of Stranger Incorporation, being a natural person competent to contract, ORIOX hereby subscribes to the formation of a corporation under the laws of the State of Florida.

ARTICLE I Name

The name of this Corporation is BHCOMMUNICATIONS, INC.

ARTICLE II Term of Existence

This Corporation shall commence upon the filing of these Articles and shall exist perpetually.

ARTICLE III Purpose

The purpose of this corporation is to engage in any activity or business lawful under the laws of the State of Florida or the United States of America.

ARTICLE IV Capital Stock

This Corporation is authorized to issue Ten Thousand (10,000) shares of One Dollar (\$1.00) par value, common stock.
