# ARTICLES OF INCORPORATION

So We So Williams The undersigned, acting as incorporators of a corporation under the Florida General Corporation, Act, adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I. NAME

The name of this corporation is A. Sharpening & Mower Repair, Inc.

# ARTICLE II. DURATION
