Pursuant to the provisions of Florida Statutes section 607.1006, this Florida profit corporation adopts these Articles of Amendment to its Articles of Incorporation.

FIRST: Amendments adopted: Article I of the Articles of Incorporation of Panhandle Powdercoatings, Inc. is hereby amended and restated to provide in its entirety as follows:

ARTICLE I

The name of the corporation is Panhandle Powder Coating, Inc. The street address of the corporation's initial principal office is 9721 Fowler Avenue, Pensacola, Florida 32534.

SECOND: Date of adoption: The foregoing amendment was adopted October 25, 1999.

THIRD: Method of adoption: The foregoing amendment was adopted by resolution at a special meeting of the stockholders and Board of Directors of the corporation on October 25, 1999. The shares of all of the common stock of the corporation, representing the only voting group required to vote on the foregoing amendment, voted unanimously for approval of the foregoing amendment.
