OF

THE UNDERSIGNED SUBSCRIBERS TO THESE ARTICLES OF INCORPORATION 3.3.
EACH A NATURAL PERSON, COMPETENT TO CONTRACT, HEREBY ASSOCIATE THEM OF SELVES TOGETHER, TO FORM A CORPORATION FOR PROFIT, UNDER THE LAWS OF THE STATE OF FLORIDA.
