Greetings,

I'm a painter. I have always done my own paperwork and prepared my own tax returns. So, when I incorporated and got behind, I took my 1998 and 1999 forms, bank statements, etc., to J&S Bookkeeping, Hawthorne, Florida. I thought I was hiring a professional. I took the work to them in late February, 2000. I kept calling to find out when I could get my tax returns. I finally got my work in July, 2000; and they even failed to get me an extension on the corporate and personal returns!!

Everything relating to the corporation is new to me. I incorporated in August, 1999. So this Uniform Business Report was the first one and I didn't know about it. I do not remember receiving this form, even after someone described it to me. If I received it, I would certainly have responded. That's why I think that if I had it, I gave it to the bookkeeping service... I hired professional help to keep me straight. I paid someone else to tell me what I needed. They weren't up to the job.

I am submitting my 2000 Uniform Business Report with the required fee. The notice of revocation was the first I knew about this. I'm asking you to please accept it as timely filed and cancel the revocation. Otherwise, the punishment sure won't fit the "crime". I was wronged by an un-professional. A reinstatement fee would mean getting wronged again by their incompetence. Or, I was wronged by the Post Office.

I know what to look for now (I will look for the brown form), and I will not let this happen again. And, I have hired a professional accountant. The new accountant said he would now stock blank UBR forms (he hadn't had to in the past).
