The undersigned; for the purpose of forming a corporation under the FLORIDA GENERAL CORPORATION ACT hereby adopts the following Articles of Incorporation:

ARTICLE ONE
NAME

The name of the corporation is ERIC N. RYDLAND, M.D.. P.A.

ARTICLE TWO
COMMENCEMENT
AND DURATION

The corporation existence shall commence on date of filing and shall be perpetual unless terminated by law.

ARTICLE THREE
CORPORATE PURPOSE

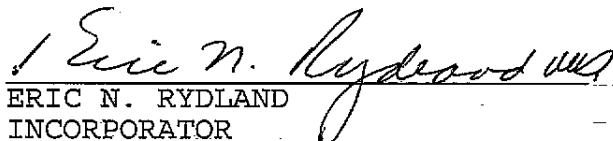
