ARTICLE I

The name of the corporation shall be:

**ARTICLE VI**

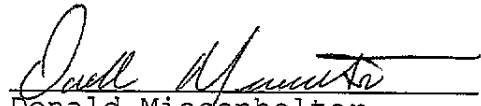
In pursuance of Chapter 48.091, Florida Statutes, the following is submitted, in compliance with said Act:
