ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be: Tenant Survival Institute

ARTICLE II - DURATION OF EXISTENCE

The commencement of corporate existence shall be upon the filing of these Articles of Incorporation with the Secretary of State, State of Florida.

ARTICLE IV - GENERAL PURPOSE

The purpose of this corporation is to engage in any activities or lawful business permitted for corporations under both the laws of the United States of American and the State of Florida.

ARTICLE V - CAPITAL STOCK

The corporation shall have authority to issue One Thousand (1,000) shares, all of one class, with a par value of one dollar (\$1.00) per share. Each shareholder of any class of stock of this corporation shall be entitled to full preemptive rights to purchase any unissued or treasury shares of the corporation and any securities of the corporation convertible into or carrying a right to subscribe to or acquire shares of any such unissued or treasury shares.

ARTICLE VI - REGISTERED OFFICE AND AGENT

The address of the initial registered office is 3677 Jericho Dr, Casselberry, Florida 32707, and the name of the initial registered agent at said office is John W. Saltman

ARTICLE VII - BOARD OF DIRECTORS

This corporation shall have two (2) directors initially. The number of directors may be increased from time to time by an amendment of the By-Laws of the corporation in the manner provided by law, but shall never be less than one (1).
