

ARTICLES OF INCORPORATION

ARTICLE ONE

The name of the corporation is FLORIDA STUDIOS, INC. and it's principal office and mailing address is 1857 Venetian Pt. Dr., Clearwater, Fl. 33755

ARTICLE TWO

The period of its duration is perpetual.
